Your attention is drawn to the following particular rules and bye-laws.

1. **Members of the Club undertake to obey the rules and bye-laws of Bala Sailing Club and any regulation or bye-law made by the Committee from time to time.** Any infringement of these, or conduct likely to damage the reputation of the Club, shall render the member concerned liable to expulsion.
2. **Children under the age of 10 must be under close adult supervision at all times. Parent or guardian must be present at all times if junior under age of 12 years**
3. Sailing Members have to carry out a minimum of three days Duty at the Club to assist with its running, for the mutual benefit of Club Members. Offers of Duty Days from Social Members are warmly received.
4. Social members are not permitted to own a boat or board at this club, nor do they have any voting rights at the club.
5. 'Group Membership' is at the discretion of the Executive Committee - apply to the Secretary.
6. Members in receipt of the State Retirement Pension are eligible for Half Membership Subscription rates. Full fees for moorings apply.
7. **Each boat or board belonging to a Club Member must display the current Boat Parking Sticker when at the Club.** This is a requirement in our lease from Snowdonia National Park. Those without a sticker will be removed and disposed of without further notice.
8. If you have any queries then please contact the Secretary, or any club officer. The club relies on volunteers for the running of racing and we request that you assist in this respect for three days each season. You will not be asked to do anything that is beyond your ability.
